SUBJECT: 2017 LEGISLATIVE SESSION – INCOMING SPEAKER OF THE HOUSE ANNOUNCES CHANGES IN COMMITTEE STRUCTURE

Incoming House Speaker Richard Corcoran announced a new committee structure for his two-year term. Under the new structure, there will be nine full committees, reduced from the current 10. The new committee structure for the Florida House of Representatives is as follows:

- The leadership team will work collaboratively on the appointment of the committee vice chairs and subcommittee chairs.

The organization session will take place on Tuesday, November 22, 2016.
